The University of Craiova, Romania, represented by Rector Professor PhD. Ion Vladimirescu, and

University of Saarland – Germany, Institute of European Law represented by professor Dr. Dr. Michael Martinek

Have agreed to conclude the following agreement:

Article 1: The aim of the agreement

1.1. The aim of this agreement is to promote, within the academic partnership sphere including research and teaching, the cooperation in the doctoral field between the **University of Craiova** and the **University of Saarland – Germany, Institute of European Law**, named further on “The Subscribers”.

1.2. The Subscribers wish, through this cooperation, to serve the common interests in what the development of some research networks and academic exchanges is concerned.

Article 2: Ways of cooperation

The projected ways of cooperation are the experience exchange for PhD students, the reciprocal support in documentation, the possibility to sustain lectures and also the cooperation in what the doctoral research is concerned.

Article 3: The experience exchange for PhD Students

The subscribers agree to the experience exchange in what the PhD students are concerned in the limits of the bilateral agreement.

Article 4: Financial and organizational agreements

4.1. This academic agreement does not lead to any financial obligation for the Subscribers. All the expenses (journey, accommodation, food, medical insurance, etc) for each PhD student will be supported by the sending institution.

4.2. The Subscribers will, previously to every exchange project, conclude an agreement between the sending faculties/departments and the faculties/departments of receipt through which they will establish the length of staying period of the person, who is going to be delegated, his/her tutor, the research field, and also all the necessary data for solving certain problems (accommodation, food, scholarship, insurance).

4.3. The Subscribers both guarantee the fact that they will use their influence in order that every academic mobility case is as favourable as possible from the financial point of view. Particularly, the Subscribers will make an effort to obtain funding and other benefits for the hosted PhD students.

4.4 If there exists a possibility of financial or any other form of support from either of the Subscribers, for the PhD students that study or do scientific research, to the present agreement will be added an additional act in which will be specified the limits of the support granted.

Article 5: Final provisions

5.1. Both institutions accept the nomination of a member from their own academic framework to become a contact person for the aim of this agreement. This agreement will be in force for five years from the date of the last signature, except the case in which it is terminated in writing by one of the institutions with a 6 months notice.

5.2. If there appear new elements which make possible the improving or diversification of the existing bilateral relations, the Subscribers will conclude additional acts to the present partnership agreement.
